6. Events:

- a. Border War: many of the reports above include Border War information. Until the final receipts are added in, the Stewards report cannot be sent off; however, there are a few things to mention now.
 - 1. THANK YOU to the whole team, I could not have managed as Steward without the assistance and effort everyone put in.
 - 2. For lists: the mess up with the Heavy tourney was because I did not have the correct tools to run a Single Kill Double Elimination tourney properly. I suggest that we get a set of 5 x 3 cards, pencils and the paperwork required and keep it in the cabinet at the hall, so that next year it is just a matter of grabbing the folder or box and taking the whole thing up, ready to be used.
 - 3. We have made around \$2.5 to \$2.7 thousand dollars profit.

7. General Business:

- a. It has been suggested that instead of Bordscros having two gatherings in two towns each month, that we have one per month; one in Albury, the next month in Wagga. The reason this has been suggested is to try to remove the 'them' and 'us' mentality that some members of the group fear is growing.
*Issues noted during discussion: what about the two venues we are renting, we will be paying

for a service we are not using. Can we afford to do that?

* The distance to be travelled between the two towns can be difficult, especially for those without transport, or short of funds. Is there a central place we could hire a hall so that each group only travels half the distance? Henty? Tamsin says not really, not with the space/kitchen requirements for a gathering.

* What about storing all the equipment, the space we have now is almost too small, so where would it go if we move?

An alternative suggestion was then made: that we have separate halls for A&S, fighter practise and monthly gatherings in each town, but that once a quarter we have a Quarter-Day Gathering that is combined.

Decided that we all need to think about this, and people from both groups need to be present for the discussion to be fair (via SKYPE or in person). Should we have an extra-ordinary general meeting just to discuss this issue? To be discussed on BUSINESS ARISING next meeting.
