Because the hoard contained coins issued in Speyer between 1347 and 1349, it is thought to have been buried by a member of the local Jewish community fleeing persecution in 1349 for the safety of a neighboring town.

CELEBRATING THE NEW YEAR

"The earliest recorded festivities in honor of a new year's arrival date back some 4,000 years to ancient Babylon.

"For the Babylonians, the first new moon following the vernal equinox—the day in late March with an equal amount of sunlight and darkness—heralded the start of a new year. They marked the occasion with a massive religious festival called Akitu (derived from the Sumerian word for barley, which was cut in the spring) that involved a different ritual on each of its 11 days.

"In Egypt... the year began with the annual flooding of the Nile, which coincided with the rising of the star Sirius. The first day of the Chinese new year, meanwhile, occurred with the second new moon after the winter solstice.

"The early Roman calendar consisted of 10 months and 304 days, with each new year beginning at the vernal equinox... A later king, Numa Pompilius, is credited with adding the months of Januarius and Februarius. Over the centuries, the calendar fell out of sync with the sun, and in 46 B.C. the emperor Julius Caesar introduced the Julian calendar.

"As part of his reform, Caesar instituted January 1 as the first day of the year, partly to honor the month's namesake: Janus, the Roman god of beginnings, whose two faces allowed him to look back into the past and forward into the future. Romans celebrated by offering sacrifices to Janus, exchanging gifts with one another, decorating their homes with laurel branches and attending raucous parties.

"In medieval Europe, Christian leaders temporarily replaced January 1 as the first of the year with days carrying more religious significance, such as December 25 (the anniversary of Jesus' birth) and March 25 (the Feast of the Annunciation); Pope Gregory XIII reestablished January 1 as New Year's Day in 1582."



For us in the SCA our New Year falls on the first of May each year, the anniversary of the very first backyard gathering that resulted in the formation of the society. And how do we celebrate it? Well, each group has its own traditions. Is it time for us in the Crossing to create a tradition of our own? Perhaps like the Romans we could decorate the hall with laurel branches (bay) and stage a raucus party?

Etymology corner

The word fee comes to us from the Old English *feoh* meaning "money, movable property, cattle" ... so next time your Doctor or Lawyer sends you his fee – and you find yourself short of cash – raid the freezer and send him a

Chirurgeon, Herald, Hospitaller, Lists, Marshall What do these offices entail?



Chirurgeon: First Aid Officer.

Check that everything in the First Aid kit is within expiry date. Provide first aid as required at bash, organise first aiders into shifts at large events. Report once a month at the meeting and then forward those reports to the Kingdom Chirurgeon once every three

REQUIREMENTS: You need mundane First Aid qualifications and email access. Time: about 1-1.5 hours if there is a tourney; 1 hour for the meeting each month; plus a bit of time to send an email to Kingdom each quarter.



Herald: Master of Ceremonies, Town Crier &/or Researcher

This is a two part job and you can do both or co-opt a deputy and do half the job each, depending on your skills and talents.

Part 1: is Master of Ceremonies and Town Crier (aka "The Voice of the Crown"). You don't need a loud voice so much as voice projection. This role includes calling out the litany at a tourney, and announcing and recording awards in courts and gatherings. At large events you organise any visiting heralds to share the load of making announcements.

Part 2: is **Researcher**. In this role you assist the populace in selecting names and devices to submit to the College of Heralds. This can seem a bit daunting, but the Kingdom has some very dedicated heralds who are more than happy to help and advise you.

REQUIREMENTS: An interest in heraldry and email access. Time: about 1-1.5 hours if there is a tourney; an occasional Seneschal's Gathering; announce the Feast; 1 hour for the meeting each month; plus a bit of time to send an email to Crux each quarter. Plus as much time as you are willing to put into research.



Hospitaller: Publicity Officer & Asset Registrar

Another two part job.

Publicity Officer: prepare press releases, flyers etc to

advertise our presence to the public.

Asset Registrar: Keep a list of the group's assets up-todate (who has borrowed what and when it is due back). Look after garb for loan to new-comers. Report once a month at the meeting and then forward those reports to the Kingdom Hospitaller once every three months. REQUIREMENTS: Have an organised mind and like lists, able to organise cleaning of garb. Time: about 15 minutes at tourney & feast; 1 hour for the meeting each month; plus a bit of time to send an email to Kingdom each quarter.



Lists: Scorer.

Watch tourneys and archery, record who won & lost. Report winners to the herald for announcement at the Seneschal's gathering, and once a month at the meeting; and then forward those reports to the Kingdom List Officer each month.

REQUIREMENTS: Time: about 1-1.5 hours watching the tourney if there is one; 1 hour for the meeting each month; plus a bit of time to send an email to Kingdom each quarter.



Marshall: Umpire.

Understand the rules of the list, take part in tourneys. Liaise with Heralds and Lists in running tourney.. Report once a month at the meeting; and then forward those reports to the Kingdom List Officer each quarter. REQUIREMENTS: Time: about 1-1.5 hours for the tourney if there is one; 1 hour for the meeting each month; plus a bit of time to send an email to Kingdom each quarter.















Its easy to see how officers help the game, but what do you get out of being an officer?

Ask any officer and they'll tell you: a sense of satisfaction and the knowledge that by our efforts our club is strengthened and our game enhanced.

TRIVIA THE FACTS

In the agricultural communities of medieval England, the most popular months for weddings were January, November and October,¹ when harvest was past and the time for planting had not yet arrived. Late autumn and winter were also when animals were usually slaughtered for food, so freshly butchered beef, pork, mutton and similar meats would be available for the wedding feast, which often coincided with annual festivals.

Summer weddings, which might also coincide with annual festivals, enjoyed some popularity, as well. June was indeed a good time to take advantage of good weather and the arrival of new crops for a wedding festival, as well as fresh flowers for the ceremony and celebrations. The use of flowers in wedding ceremonies goes back to ancient times.² Depending on the culture, flowers have numerous symbolic meanings, some of the most significant being loyalty, purity and love. In the late fifteenth century, roses were popular in medieval Europe for their connection to romantic love and were used in many ceremonies, including weddings.

As for "yearly baths," the idea that medieval people rarely bathed is a <u>persistent but false one</u>. Most people washed themselves on a regular basis. Going without washing was considered a penance even in the early Middle Ages. Soap, possibly invented by the Gauls sometime before Christ, was in widespread use throughout Europe by the end of the ninth century, and made its first appearance in cake form in the twelfth century. Public bathhouses were not uncommon, although their ostensible purpose was often secondary to their clandestine use by prosititutes.³

In short, there were numerous opportunities for medieval people to cleanse their bodies. Thus, the prospect of going a full month without washing, and then appearing at her wedding with a bouquet of flowers to hide her stench, is not something a medieval bride was likely to consider any more than a modern bride would.

Recipes

roasted beetroot with garlic and greens

This is not particularly a medieval recipe – but it is the type of food that a peasant with their own vegie patch might cook and eat – especially as none of the plant is wasted.

Ingredients

- 1 bunch young beetroot with the greens
- 4 Tbsp olive oil
- 2 cloves garlic, crushed
- ½ red onion, chopped
- Salt & freshly ground black pepper (to taste)
- 1 Tbsp red wine vinegar (optional)

methos

- 1. Preheat the oven to 180 C. Wash the beetroot thoroughly, leaving the skins on, and remove the greens. Rinse greens, removing any large stems, and set aside.
- 2. Place the beetroot in a small baking dish or roasting tin, and toss with 2 tablespoons of the olive oil. (If you wish to peel the beetroot, it is easier to do so once they have been roasted.) Cover, and roast for 45 to 60 minutes, or until a knife can slide easily through the largest beetroot.
- 3. When the roasted beetroot are almost cooked, heat the remaining 2 tablespoons olive oil in a frying pan over medium-low heat. Add the garlic and onion, and cook for a minute. Tear the beetroot greens into pieces, and add them to the frying pan. Cook and stir until greens are wilted and tender. Season with salt and pepper. Serve the greens as is, and the roasted beetroot sliced with either red wine vinegar, or butter and salt and pepper. Depending on serving size serves about 6-10

chicken thighs in Lemon sauce: ingredients:

Chicken thighs (or sliced breast or drumsticks) browned in a little oil (At Border War we cut the thighs in thirds so they would go further – for a quick family dinner cut up a cooked chook)

for the sauce:

1/4 lb. melted butter

¹/₈ tsp. garlic powder (or a clove of crushed garlic)

1-1/3 tbsp. sugar

Pepper to taste

1/4 c. white wine

3 lemons, squeezed

Lemon wedges to garnish



methos

Combine sauce ingredients in pot on stove until warm. Pour sauce over chicken in shallow baking dish. Cover and bake at 350 degrees F (180 degrees C) for 20 minutes.

May be cooked ahead of time, frozen and reheated in a medium oven.

Well, for one thing – they are a lot of fun to make and to play games with afterwards. Especially when its cold and wet outside and you are stuck inside with nothing to do.

Some of them are very complicated and need special equipment; BUT you can make a simple papier mache diorama with flour and water (or craft glue), an empty cereal box, paper towels and empty toilet rolls.

Here is a picture of a diorama of Helm's Deep - the fortress from Lord of the Rings:

You don't have to make Helm's Deep, you could make your own fantasy castle or a dragon's lair.

Don't forget to put some paper or a sheet of plastic down first to protect the table you are working on, and you might need to ask a grown up to help you with some of the harder bits.

Bordescros Campsite Improvement Challenge @ Festival 2014

April 18-21, "Wombaroo" Southern Highlands, NSW Proposal by Elizabeth de Bohun

As some of you may know, several years ago I accepted a protégé challenge from my Mistress to investigate and coordinate improvements for the Bordescros campsite at Festival. With a move to a new Festival venue, and some increased interest from other members in this project, I would like to rekindle the Bordescros Campsite Improvement Challenge in 2014.

Many other campsites have fantastic schemes in place. I have camped with, and spent time in, other campsites to see how these work in practice. I have been lucky enough to be given organisation packs from other groups about their Festival plans and, most importantly, I've had feedback from Bordescros members about what has and hasn't worked at past Festivals and what has the potential to work for us.

I would like to start on the conservative side and implement a few well-chosen ideas to address issues that have been identified by Festival attendees in the last few years. There is room to grow and introduce further plans in the future. I hope to make the camping experience more stream-lined and a collaborative effort so it is less stressful and thus more enjoyable for all.

I appreciate all feedback. If you do not agree with a proposal, please suggest an alteration or alternative which you feel will be more beneficial to our campsite.

New Festival Site

Rowany has confirmed that Festival is moving to "Wombaroo" in the Southern Highlands, near Mittagong, for the next five years. The new site is approximately 4.5 hours from Albury and 3.5 hours from Wagga Wagga. "Wombaroo" has been chosen because of several major benefits it offers:

- There is already plenty of infrastructure in place such as a hall for the tavern, fire pits, commercial kitchen, A&S rooms and the owners are open to further development such as a forge and bread oven being constructed
- There is onsite lodge accommodation which will be made available first to those with health concerns and long distance travellers. There is power on site for medical equipment
- It is a private and exclusive site, so it offers increased security and no mundane intrusions
- There is a fenced dam for swimming, which is far safer than the open dams and rivers offered at previous sites (a relief to many parents)
- There are onsite showers with endless hot water and normal toilets. Definitely not sufficient number for all campers, but a great option for anyone who is not fond of normal camping amenities.

The climate is mild to cool (8-20 degrees). The site covers 125 acres and is accessed by a gently winding road. It is drier than Glenworth Valley, with about half the average rainfall experienced at that site, and grassier than Crossroads, with some lightly wooded areas. At James Douglas's suggestion we are requesting a campsite not too far from the main action and relatively close to the swimming hole.

Major Proposals

- 1. Camp Management team. We establish a dedicated Festival team consisting of:
 - Camp Wrangler (Elizabeth de Bohun) who will be in charge of the overall co-ordination of the campsite, organise planning sessions, and work with all other team members to ensure the feedback and suggestions of the populace are being taken in to consideration
 - **Kitchen Captain** (Isabel de Beaumont) who will manage the kitchen operation, improvements and equipment. The Kitchen Captain will work with all attendees to co-ordinate Shire Night
 - Warlord (Iames Douglas) who will co-ordinate our warband both in training and on the warfield. The

- Warlord will identify & organise solutions for fighters' specific needs at Festival
- Further team positions may be appointed as the planning sessions continue, if we find there are particular areas that need special attention.
- <u>2. Amenities fund.</u> We start an amenities fund which everyone camping with Bordescros will contribute to. The fund will be used strictly for Festival-specific amenities such as communal gas bottles, trestle table hire, and anything else the group deems necessary but it will not cover food. Affordability of the fund will be a high consideration as it is not the aim to exclude anyone financially and the amount will be decided once the group decides what amenities are needed.
- 3. Food. Food organisation will continue as it currently is which is generally a mini-food-fund between friends and households which most of us pot luck. On one night of Festival we will have a Shire Night, a feast for all those camping with the Shire and their invited friends. The Kitchen Captain will organise coordination of this meal in advance.
- <u>4. Roster.</u> We already utilise an unofficial roster system where we share duties, an official roster would just be a little more structured and is used very successfully in a lot of campsites to ensure all tasks are covered and also to make the campsite less crowded at heavy chore times (such as post-dinner dishwashing). Our roster would be voluntary so we'd have the greatest flexibility to accommodate people's activities and commitments elsewhere and would be for tasks such as dishwashing, water haulage, fire minding etc.
- 5. Campsite improvements. The top priorities, based on the issues identified in the past few years, are:
 - A Great Hall for meals and bad weather activities. We will investigate the suitability of tents we
 currently have in the Shire, or possibly consider hiring a tent at Festival, based on the cost, which
 would be covered by the amenities fund.
 - A designated kitchen tent separated from the Great Hall to avoid dishwater making the ground wet.
 - A bathroom tent set up with a shower area, dry area for changing, and a sink for brushing teeth/hand washing.
 - Armour storage tent.
 - A fence (possibly hessian or brush fencing) between us and neighbouring campsites, so we are not used as a thoroughfare. Bunting or similar on the perimeters facing walkways to create a boundary without blocking us off completely.
 - Improving the appearance of the campsite by creating an entrance, having our most period tents on display at the front, lighting the campsite with lanterns and making a better display of any banners we have.
- 6. Preparation for Festival. We will check all group equipment and any donated equipment that is being taken to Festival at the A&S after Border War to make sure everything is in good working order and that we are aren't doubling up or missing any essential equipment. The weekend before Festival we'll have a group packing day to co-ordinate who is transporting the equipment and make a checklist so we can ensure everything comes home and is returned to the correct owners. Checking and packing your individual equipment is entirely up to you and will not be part of the group check & pack days.
