		MOTION: That Julie Willis of north Bordescros apply for the position of Treasurer for the whole club and keep an updated copy of the books on Dropbox that can be accessed by North and Central groups, and that Tracey Sawyer of Central Bordescros be Deputy Treasurer and report to Julie Willis. 2. At a previous meeting (August 2013) it was moved that we change our bank over to Westpac in line with the Kingdom Exchequer as requested by OZIBoD. Rhonda Drewe had no success trying to get account details from the OZIBod treasurer. Julie Willis will contact the current Exchequer to make the change. She will also discuss separate accounts for each group within the Shire of Bordescros. Rhonda will check both Hume and Westpac to compare costs and fees, and will report back to Julie as the new Reeve.

Central 3. Re: phone call from Albury Wodonga Sport Fishing Club. Ross White is the new Treasurer of AWSFC and phoned Tracey Sawyer regarding late payment of rent. He detailed the last 3 cheques paid: Nov 2012 \$750.00 for 9 months to January 2013 at \$250 per quarter. At that time

the rent was raised to \$350 per quarter. Feb 2013 \$350.00 paid to end of April 2013.

Dec 2013 \$700.00 paid for 2 quarters to the end of October 2013. Mr White suggested that we pay two months to the end of Dec 2013 to bring the quarters into line with the financial year, and also pay for 2 quarters to catch up. To bring us into line with our agreement to pay one quarter in advance we actually need to pay:

Julie Willis to look at setting up regular automatic payments when the new account at Westpac is opened. This will be discussed at the next meeting after the account is moved.

## OTHER BUSINESS: 1. If we are to introduce online meetings the group will need to buy a 'dongle' for internet access so that on-line meetings can be held and both halves of the Shire, and all officers, can take part. Tamsin Walle suggested that the meeting be moved to more suitable time for everyone, so that Julie Willis can also attend via internet, she offered that the meeting be held at her home which has wi-fi access. After a brief discussion it was decided the meeting will be held on the Monday night after the 2<sup>nd</sup> Sunday of the month at 7:30 pm at Tamsin's or on-line via Skype.

2. Due to illness the Seneschal, Rhonda Drewe, will be stepping down earlier than planned. After a discussion it was decided the position of Seneschal will be taken on by Tamsin Walle-Semmler, who will therefore need to step down as A&S officer. Rhonda believes she should be able to manage the role of A&S officer, despite her illness, and will take on that role if every one agrees. This will take effect straight after the meeting. The appropriate applications will be forwarded to the Kingdom Officers for the change to take place.

MOTION: That at the close of this meeting, Rhonda Drewe will step down as Seneschal and Tamsin Walle-Semmler will step into that role, and all paperwork required will be completed as soon as possible. MOVED: Rhonda Drewe SECOND: Tamsin Walle Unanimous.

The Siege of Harfleur, the battle at the ford, field battles, an Agincourt run, etc. At the beginning of, or during water breaks in, some scenarios I would like the famous speeches from Shakespeare's Henry V to be included to inspire the fighters: e.g. Once more into the breach... and St Crispin's Day...

The Bardic Challenge and A&S are to be themed around the events of 1415 as well. A&S may include: cooking, brewing and some children's activities that will be judged in the A&S competition. After last BW, an offer was made to conduct at least one rapier collegium or even several rapier collegia throughout the weekend.

In keeping with the theme, archery at the butts as well as Combat archery are to be included.

Food will be as last year, and assistance will be required in the kitchen, especially on the Friday for prep, and volunteers for the other meals.
